

Jan. 20 - Azerbaijan Martyr's Day

Jan. 20 - Martin Luther King Jr. Day

Mar. 21 - South Africa Human Rights Day

This day commemorates the Sharpeville Massacre of 1960, where 69 peaceful protesters were killed and 180 wounded by police during a demonstration against apartheid pass laws. This day serves as a solemn reminder of the sacrifices made in the struggle for democracy.



Chatting with Franco

A column dedicated to the thoughts and writings of Franco Cicchiello from our Barcelona office. Reach out if you would like to contribute too!



Italians

This man is Italian. I must confess, I am imagining you seeing him and making a comment like: "Oh yeah! Here's the typical Italian gangster. Like Don Vito Corleone, in the Godfather!".

His family immigrated in the U.S. in 1869 and he was born in San José in 1870 and he is no criminal.

Please listen to this story:

This man is Amadeo Peter Giannini, the founder of the Bank of America, one of the largest banks in the world.

His career is a free business course mixed with immortal quotes that are still valid after all these centuries. He represents a good example of what it means to be Italian.

His father was killed when he was 7 years old for a credit of 1 Dollar and it forced him to grow up fast.

He was an intelligent and hard worker who built his fortune in the Fruit and Vegetables market. He founded the Bank of Italy in 1904 because he had a different idea of banking in mind and started working based on a "contrarian" philosophy.


He said, "The banks give money to the rich because they think it will be easier to get the money back but, in a country where you can lose life for 1 Dollar, the poor will die before not giving your money back to you".

The turning point was on the 18th of April 1906. When the city of San Francisco was devastated by the worst and deadliest earthquake in the history of the United States. 3,000 people died and 80% of the city was destroyed and burnt. While all the major banks were stopped, Mr. Giannini could quickly recover his few gold bullions, load them on a fruit chariot and take them home.

He also recovered a half-burnt Bank of Italy Sign and after just a few days from the earthquake, he went downtown San Francisco and, with a table, with the sign and with a panel saying, "we're in business as usual", he started lending money to the people of San Francisco that needed a fresh start after the tragedy.

His fame grew incredibly. He was previously well known by the Italian community but now he was known by everybody, and his business grew up as also his popularity did.

In 1909 he started opening branches of the Bank of Italy and in 1918 he was the owner of the main bank in California.



Then, in 1920 Mr. Giannini discovered the potential of the cinema industry.

He received a visit from star, Charlie Chaplin who had written "The Kid". Giannini gave him the financing to be reimbursed with a percentage of the benefits from the film. It took him only a few days to get his money back.

Some years later he became a good friend to Frank Capra and Walt Disney of whom he financed the first full length movie Snow White.

In 1930 Bank of Italy took the name of Bank of America National Trust and Saving Association.

And just two years later, Mr. Giannini met an engineer named Joseph Strauss that was looking for a financial operation for his project: a suspended bridge joining the San Francisco Peninsula with the Marin County: The Golden Gate.

Giannini asked: "How long will this bridge last?" and, when Joseph Strass answered "Forever", he financed the operation with 35 million USD instead of the 32 requested but, under one condition, to have the workers of San Francisco employed on the bridge. These workers were also the customers of Bank of America to whom he had lent the money. This is very Italian, isn't it?

In 1945, he founded the Giannini Family Foundation with the purpose of promoting the medical research. The foundation is still active today. And in October 1945, at the age of 75 years he retired leaving the biggest bank in America at that time.

He died years later in 1949 but his philosophy always remained. He changed the banking industry forever. Among the many quotes that he left, the best ones, for me are the following:

"You do not own a big fortune; you are owned by it",

"Money is not created with cunning, but first with hard work and then with wisdom" or, last but not least,

"A banker should consider himself a servant of the people, a servant of the community".

This man was not only a genius but also an example of what Italians can be.

I want to conclude this with my thought about America. He did what he did because in the United States, if you are good at doing something, you can do it. I think that the story would have been different in Italy because, in my country, if you don't know anybody, you can do nothing.



The Legend of the Drifters

The sound of the oars penetrating the water is like a "splash". It is followed by the squeak of the oar turning in the oarlock and then by the order of the cox swain.

The sequence is rhythmic and hypnotic, and this cycle has been going on for more than three hours now.

This afternoon the Italian boat is out for a cool down ride. The trainers and managers had seen the boat leaving the training base of the city of Pallanza on the Lake Maggiore (This is also the place where I was born) but, now, not seeing the 8+ crew coming back, the team ashore begin to worry.

They make the decision, "Let's take a motorboat and go look for them"

They reach the Italian boat when they are close to the Swiss border.

"Hey crew! You need to stop this thing, whatever it is you are doing!" These are the first words of the Italian trainer.

Then the manager of the national team carries on telling the crew off.

"You are representing Italy at the Olympic Games for the year 1932 in Los Angeles! The United States: do you understand? Are you crazy?" but the fury is not over because, once back at the training base, the 9 guys are gathered in a meeting room and the scolding picks up again.

"If you don't want a serious punishment, you tell me what's happened... and the explanation must be very persuasive! Now: can anybody tell me what's the matter?" A manager yells.

The cox swain takes the word and says, "Sir! With all due respect, it's my fault because I saw that they were rowing incredibly well and fast and so, to motivate them to do more, I said, 'Guys! The mother of the first one that gives up is not a serious woman!' The boys took it seriously".

The team manager calmed a little bit down but still wanted to know more.

"You all come from the city of Livorno, don't

you?"

"YESSIR!" the crew replied as one.

Then came the final speech that closed the meeting:

"I know you are all dock workers and you are called "The Drifters" because your rowing technique is rough, but you are the best we have in our country now and, even if you are non-conventional, here we want DISCIPLINE ! Do you understand me?"

"YESSIR!" was the answer. And then they were allowed to leave the room.

On their way back, the 9 guys from Livorno were pretending to be sad but, secretly, they were winking at each other and smiling, just like the schoolfellows that have escaped the teacher's wrath.

Then the day came.

On the 13th of August 1932, the Drifters were in the final against the famous crew of the California University of Berkeley representing the United States. The Americans won by 2 hundredths of a second but, since the technology was more limited than today, at the time, it took a while before the 130.000 spectators of the Marine Stadium of Long Beach could burst out into the applause for the victory.

Four years later, the Drifters went to the Olympics of Berlin 1936.

They had 2 goals in that case: the first one was to beat the Germans and the second one was to take the Gold Medal home.

They reached only the first one because, in the final, they lost to the crew of the Washington University representing the United States by 7 hundredths of a second.

Their final record was: Two Olympic Silver Medals, two European Championships and 12 Italian Championships. They remain the best-ever 8+ Italian Crew.

If we want to get a lesson from this story, the one I'd choose is that, "There is one thing that we never have to do, and, especially when the honor of Mummy is involved, NEVER GIVE UP!"

An Introduction to Flawless Execution

Does your team have a clear process for daily tasks? Just as importantly, do you hold regular debriefs to gather feedback and share insights up the chain of command? Without structure, teams often become overwhelmed. Leaders should document key workflows, invite team input, and formalize the process—creating a shared understanding that improves efficiency and continuity.

Cross-training ensures the team can adapt when someone is unavailable, and regular debriefs help refine the process over time. As Murph puts it, this approach “tightens plans, builds adaptability, and makes each mission easier than the last,” keeping your team ahead of the curve.

Flawless Execution requires intentionality. It must be driven from the top down—not the bottom up. Leaders at all levels should set aside time each week to discuss these initiatives. By doing so, you may eliminate threats, boost efficiency, raise morale, and gain valuable insights that might otherwise be missed.

Most businesses rarely view execution as a process, and even fewer take the time to debrief after major projects. Be different within your business unit. Step into a leadership role by promoting communication both up and down the chain of command—it makes everyone's job easier.

Finally, never overlook the foundation of the pyramid. Without strong PEOPLE and effective TRAINING, it's impossible to establish and uphold high STANDARDS. Small-unit leaders: take time to share your personal experience and expertise. Support your team through consistent, intentional training. The impact is immeasurable.

Future Picture

Rule 2: Define the Vision with 12 Key Descriptors

2. Market Position	6. Outsider Perception	10. Corporate Citizenship
3. Business Areas	7. Workforce	11. Ownership
4. Innovation	8. Brand	12. Incentive Philiosophy

Rule 3: Use Measures of Merit (MOM)

Each key descriptor needs a Measure of Merit—a specific, trackable indicator of progress. These MOMs drive accountability and help connect organizational goals to individual execution.

Example - Workforce Characteristic

Key Descriptor: Passionate, self-starting employees with strong backgrounds in accounting and/or business.

MOM:

- Volunteer speakers promoting the company
- New business proposals submitted and approved
- Ongoing professional development

Tasks Supporting This MOM:

- Roger Nixon will deliver a speaking engagement to NCMA by 2026
- Roger Nixon will submit 20 business proposals by 2026
- Roger Nixon will complete 20 hours of proposal training by 2026
